EXECUTIVE SUMMARY

During the fiscal year 2023-2024, the Balochistan Public Procurement Regulatory Authority (BPPRA) made witnessed enhanced procurement NIT compliance and transparency. The NIT rule compliance rose from 72% to an impressive 87%, largely due to the implementation of the Electronic Public Procurement System (ePPS). Notably, ePPS fostered heightened competition in the bidding process. E-bids attracted an average of 3.8 bidders per tender, compared to 2 bidders in manual tenders. In the same connection, 8,131 tender were published by the Procuring Agencies and 1,110 tenders were cancelled. 7,021 tenders were proceeded for bidding process on the BPPRA website.

The caretaker Prime Minister of Pakistan Mr. Anwar ul Haq formally launched epps in December 2023, which has already been revolutionizing public procurement across Balochistan since February 2022. Furthermore, Balochistan took a pioneering step by initiating the MAPS Assessment of its procurement regime, with support from the World Bank and the Asian Development Bank. This strategic initiative will elevate BPPRA's standing on the global stage, earning international recognition for its efforts to align with global procurement standards and best practices.

Despite a reduction in the total number of tenders floated—attributable to the general elections—BPPRA facilitated 8,131 tenders worth a cumulative value of 188 billion rupees. The introduction of ePPS marked a substantial improvement in the procurement process, leading to increased speed, efficiency, and transparency. E-bids, for instance, reduced the time from tender publication to evaluation to just 20 days and similarly 22 days for manual bids. Additionally, e-bidding resulted in significant cost savings, particularly for Works tenders, where 2.6 billion rupees were saved through more competitive pricing.

Among the departments, the Irrigation Department floated the largest tenders, totaling 72.5 billion rupees, while the Public Health Department processed the highest number of tenders, with 1,268 tenders worth 12.5 billion rupees.

Overall, the transition to ePPS has positioned BPPRA as a leader in procurement reform, ensuring more transparent, competitive, and efficient public procurement processes for the future of the province.

REVITALIZING BALOCHISTAN'S PROCUREMENT SYSTEM

INSIGHTS FROM YEAR 2023-24

The procurement landscape for FY 2023-24 remained relatively subdued, largely influenced by the election year. However, a notable resurgence in procurement activity was observed post-April 2024, as evidenced by a marked increase in the issuance of tenders. Despite this, it is concerning that many departments did not capitalize on the earlier part of the year to proactively plan and engage in their procurement activities. With ample time at their disposal, only 26% of awards were uploaded on the ePPS, a figure that reflects missed opportunities and requires attention.

Additionally, as outlined in the report, several Procuring Agencies evaluated bids with “zero” amounts, an issue that raises serious concerns. This suggests a significant lapse in compliance with procurement rules after bids have been opened, despite the fact that compliance during the bid preparation stage was relatively strong, reaching 87%. Furthermore, nearly 1,269 tenders were evaluated with participation from only a single bidder, the majority of which were processed manually.

This raises questions about the overall procurement practices and adherence to standards. A thorough review of the rules, particularly concerning tenders with limited bidder participation, is strongly recommended.

Moreover, the reluctance of some agencies to utilize e-bidding, even when it would have been advantageous based on expected bid prices, underscores the need for stronger compliance measures. To address this, the introduction of regular audits and stricter penalties would be effective in ensuring that procurement rules are adhered to, mitigating issues such as zero-amount bids or delays in the publication of contract awards.

A further area for enhancement is the integration of sustainability and ethical procurement criteria into the procurement framework. Aligning policies with international best practices in these areas can improve both social and environmental outcomes, providing long-term benefits to the community and the environment.

As the Electronic Public Procurement System (ePPS) is evolving into a more mature and refined platform, it is imperative to invest in advanced security measures to protect digital procurement processes and ensure data integrity. With increased reliance on digital systems, the risks of data breaches and cyberattacks are heightened. To mitigate these risks, robust security protocols and regular system audits are essential, ensuring a secure and trustworthy digital procurement environment.

On a more positive note, participation in e-bidding has continued to grow, with an average of four bidders per bid. This increase in competition has resulted in greater cost savings per bid. It can be reasonably concluded that transitioning all manual tenders to e-bidding could generate significant savings for the Government of Balochistan through more competitive bidding practices.

Looking ahead, as more data becomes available and with the integration of UNSPSC codes, we aim to introduce “price benchmarking” in the coming fiscal year.

This will empower Procuring Agencies to access historical pricing data for similar products or services, enabling them to better forecast budgets and compare bidding practices, thereby enhancing overall procurement efficiency.

Additionally, the Balochistan Public Procurement Regulatory Authority (BPPRA) is currently undertaking the Methodology for Assessing Procurement Systems (MAPS) assessment, with results expected by the first quarter of 2025. This comprehensive evaluation will provide valuable insights into the strengths and weaknesses of the current procurement framework, guiding future reforms and policy enhancements. The findings from this assessment are anticipated to help align Balochistan’s procurement regime with international standards, further improving transparency, efficiency, and accountability in public procurement.

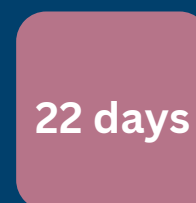

Bid Process Time from Opening to Evaluation

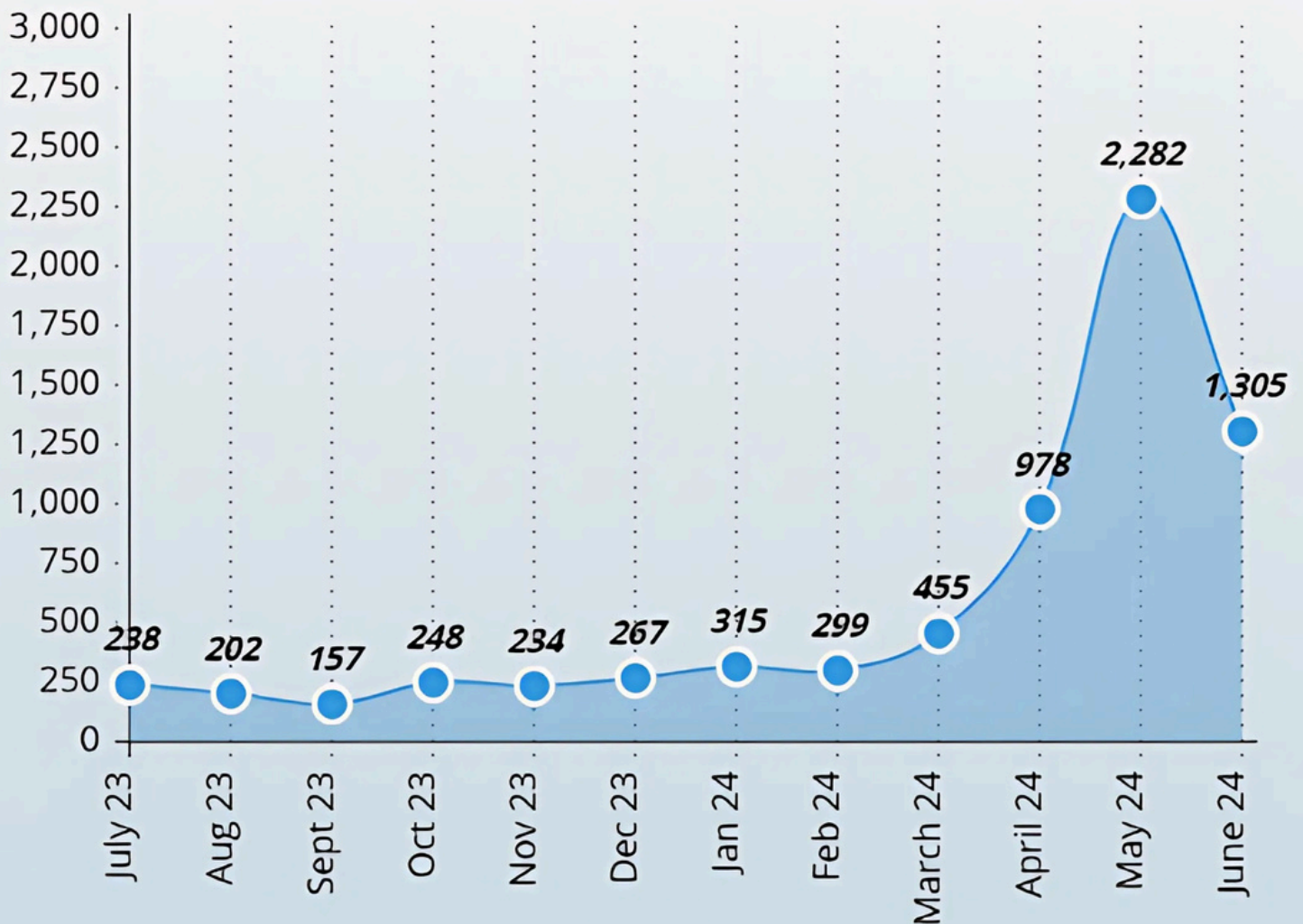

The chart illustrates a clear trend in tender uploaded in the fiscal year 2023-2024, with a significant surge in activity during the final three months i.e. April, May and June. This suggests that annual plans are often not uploaded well in advance, leading to a rush to publish tenders closer to the fiscal year end. This practice not only undermines value for money but also places an undue burden on procuring agencies. The increased workload during this period can heighten the risk of errors in bid documents and potentially compromise transparency and fairness in the procurement process.

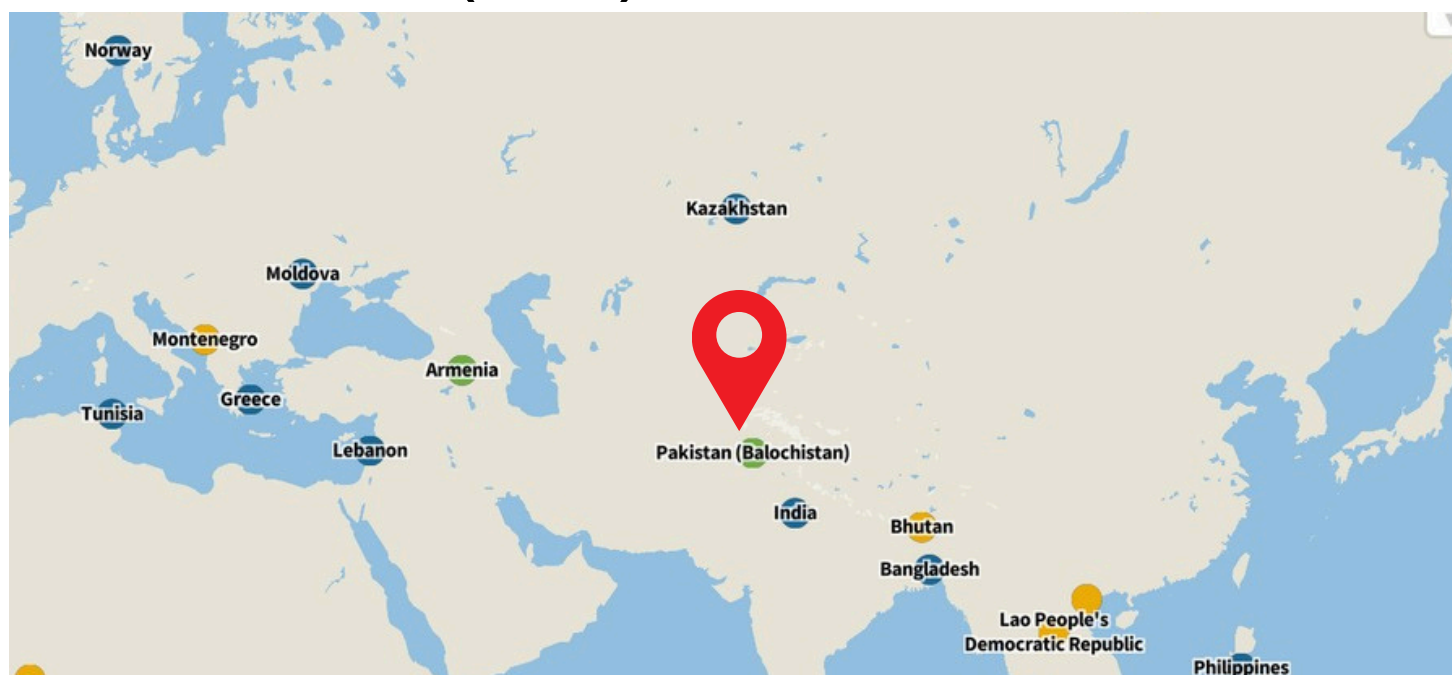

Methodology for Assessing Procurement Systems (MAPS) For Balochistan

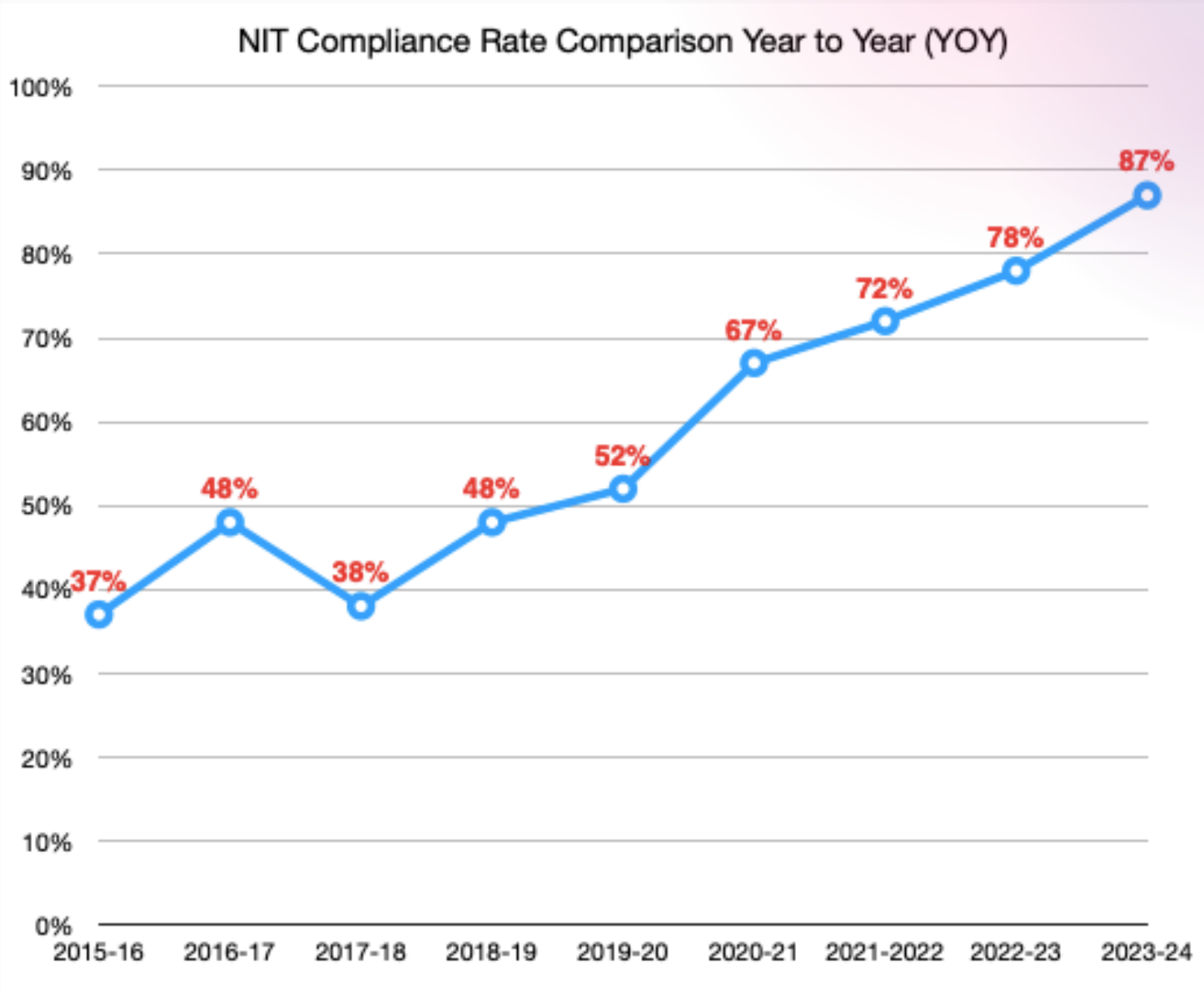


The World Bank (WB) and the Asian Development Bank (ADB), at the request of the Government of Balochistan, initiated the Methodology for Assessing Procurement Systems (MAPS) assessment for the Balochistan Public Procurement Regulatory Authority (BPPRA). This made BPPRA the first authority in Pakistan to undergo this assessment. The establishment of a Steering Committee and Working Groups signified the committed approach to enhance the procurement systems in the province. BPPRA with the support of the WB and ADB held first Working Group workshop at Quetta on May 3rd 2024. The expected benefits, including improved efficiency, transparency, cost savings, capacity building, regulatory compliance, and economic growth, highlight the transformative potential of the MAPS assessment. Balochistan's pioneering efforts set a national benchmark, paving the way for broader adoption of best practices in procurement across Pakistan.

Key advantages of the MAPS:

- **Streamlined processes:** Improved efficiency and reduced cycle times in procurement.
- **Enhanced decision-making:** More informed and strategic procurement decisions.
- **Increased oversight:** Improved transparency and reduced corruption risks.
- **Stakeholder confidence:** Increased trust among stakeholders.
- **Compliance with standards:** Adherence to national and international standards.
- **Economic development:** Contributions to the economic growth of Balochistan.
- **Improved governance:** Enhanced transparency and accountability.
- **Sustainable growth:** Promotion of sustainable procurement practices.

By addressing these areas, the MAPS assessment will contribute to significant improvements in Balochistan's public procurement Regime.



In analyzing the Yearly Rules Compliance Graph, a striking trend emerges: this year, the NIT compliance rate has reached an impressive 87%, marking a significant improvement compared to previous years when compliance rates were notably lower. The key factor contributing to this achievement is the implementation of the Electronic Public Procurement System (ePPS), which has streamlined processes and significantly enhanced compliance capabilities.

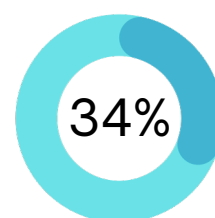

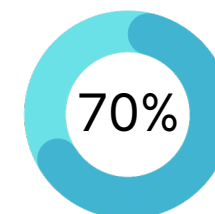

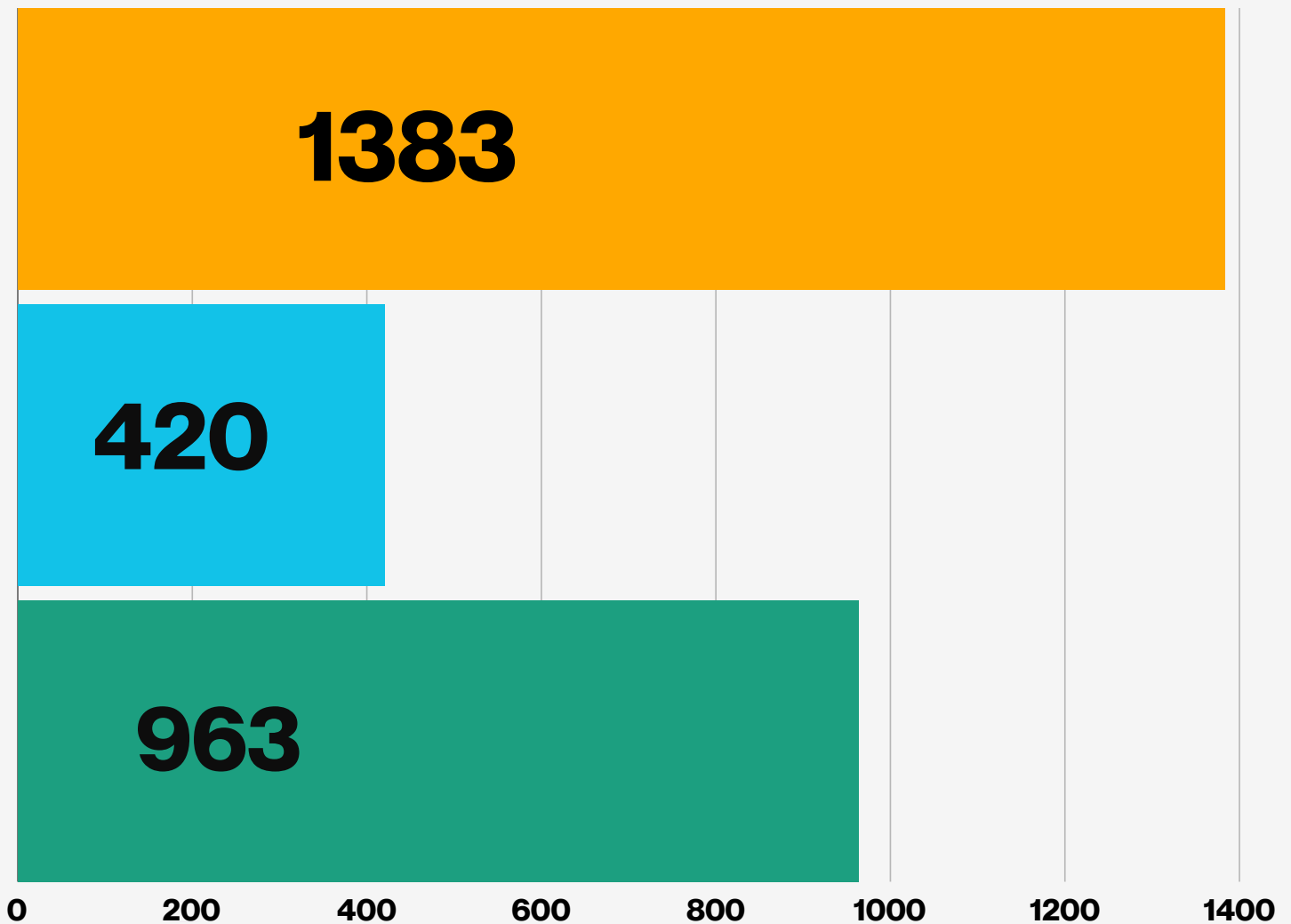

Major Rules Violations Procurement Category wise

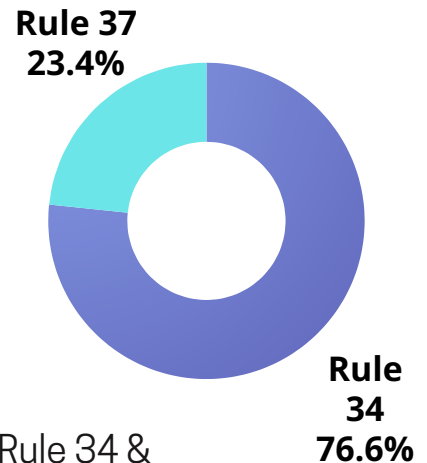

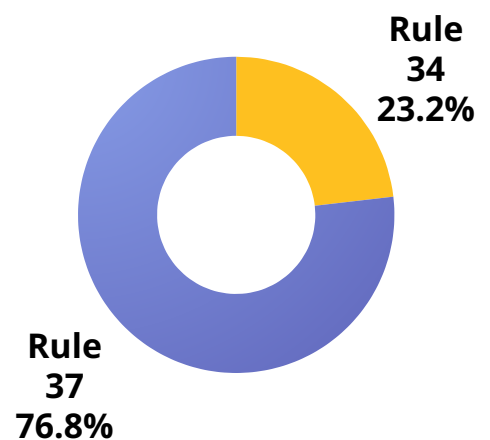

Non-Compliance Department Wise

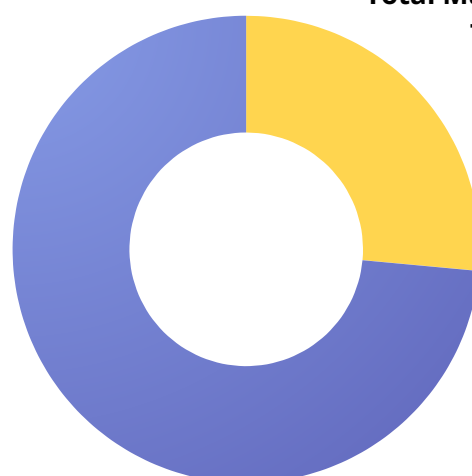

- **Contract Award:** The Procuring Agencies (PA) tend to violate Rule 10 and 49 of BPPRA Rules 2014. The PA seem to consider the evaluation report as contract Award.
- **Single Bidder :** 1138 Tenders of manual bids worth 10 billion were evaluated with single bidders and similarly 131 tenders with e-bids worth 20 Billion were also single bidders. A lack of competition in tenders can lead to higher prices and reduced quality. It is essential to ensure that procurement processes are competitive to achieve the best possible outcomes. **Rule 10(1):** This rule requires procuring entities to take steps to ensure that procurement proceedings are competitive.
- **Redressal of Grievances and Disputes:** Under **Rule 56** of BPPRA Rules, the notified committee has to announce its decision against received grievance within the stipulated time and intimate the bidder and the authority about the decision. Unfortunately, the slow response of the committees is not only causing transparency issues but also delays in execution of projects, as the bidders get into further litigation in the court of law.

KEY AREAS THAT NEED IMPROVEMENT

- **Bids Evaluation above the Estimation:** A review of 390 tenders revealed that their evaluated amounts exceeded the approved budgets. This suggests potential deficiencies in budgeting or procurement planning, which led to cost overruns and financial losses for the procuring entity and as a result impacted overall savings in procurement process.
- **Tender Cancellation:** Out of total 8131 tenders 1110 tenders were cancelled which is 14% of the total published tenders. Tender cancellation process is costly as it involves cost and time.
- **Non Responsive Tenders :** 334 Tenders were non responsive Non-responsive tenders can delay the procurement process and increase costs. It is important to ensure that tender documents are clear and unambiguous to minimize the number of non-responsive bids.
