NOTIFICATION

NO.BPPRA/FIN/CMS-1/2025/9032-41. In continuation of this office previous notification No. BPPRA/Admn/1-30/9561-70 Dated 05th September 2023 and in compliance with the decision in BPPRA 15th Board of Directors Meeting held on 06th May 2025 under the chairmanship of Worthy Chief Secretary Balochistan, the BPPRA "Challan Management System (CMS)" in connection with collection of fee from Procuring Agencies, Contractors and Suppliers on account of Tender Uploading & Cancellation, Supplier/Contractor Registration & Annual Subscription are hereby implemented with effect from 01st July 2025.

TORs:

- The system-generated fee challan must be paid at any branch of the National Bank of Pakistan (NBP) nationwide during their working hours.
- All fee payments in connection with Registration, Annual Subscription, Tender Uploading and Cancellation Fees, will be handled through automated API integration between the National Bank of Pakistan and BPPRA ePPS. No manual submission of payment receipts is required. The system will automatically reflect the payment status upon successful transaction confirmation from the bank on Real-time basis.
- The procuring agencies are required to pay the tender uploading fee after the publication of tender and before the tender opening date. Failure to do so will prevent the concerned procuring agency from opening and subsequent evaluation of the Tender.
- All suppliers and contractors must pay the registration and annual subscription fees as applicable.
 Failure to make these payments will result in the suspension of their ePPS access level until the dues are cleared.
- All payments of fee are non-refundable.
- It is the sole responsibility of each user (Procuring Agency, Supplier, or Contractor) to ensure that all payments are made on time. No exceptions or manual overrides are possible once the system enforces restrictions due to non-payment.
- Any discrepancy or dispute regarding payment status must be reported in writing through official channel. However, such disputes do not exempt users from applicable deadlines or consequences of non-compliance.
